the defunct Local Authorities as well as the Constituency Development Fund (CDF) in the County but were never completed and have since stalled, following the transfer of functions from the National Government to the Counties; noting that public funds were already spent in the stalled projects; concerned that the funds already used in the stalled projects will translate into waste if the projects are not completed for use by the community; this County Assembly urges the County Government of Makueni to make an inventory of all such projects that fall within the mandate of the County Government and plan for their completion in the subsequent Financial Years,
