- ii. **AWARE THAT**, Article 43 (1) (f) of the Constitution affirms the right to education and obligates the State under Article 21 to observe, respect, protect, promote and fulfil the rights and fundamental freedoms outlined in the Bill of rights;

COGNIZANT OF THE FACT that the County Government of Makueni allocated Kshs. 50 M in the FY 2017/2018 for bursary, **FURTHER COGNIZANT OF THE FACT THAT** around 300 students from each Ward benefited in the said FY year;

ACKNOWLEDGING that in the FY 2018/2019 the County Government allocated Kshs. 12 M which can only benefit around 60 students per Ward; **OWING TO THE FACT THAT** students in day schools in the FY 2017/2018 never benefited leading to a larger number of expected applicants in the current FY;

FURTHER aware that there are many needy students in the County who would require over Kshs. 50 M as support from the County Government in form of bursary;

APPRECIATING that Section 8 (1)(c) of the County Governments Act, 2012 provides that *the County Assembly shall approve the budget and expenditure of the county government in accordance with Article 207 of the Constitution, and the legislation contemplated in Article 220(2) of the Constitution, guided by Articles 201 and 203 of the Constitution;*

FURTHER APPRECIATING that Section 135 of the Public finance Management Act, 2012 allows the County Government to submit to County Assembly Supplementary Budget in certain circumstances;

NOW THEREFORE, this Assembly urges the Executive Committee Members for Education, Youth, Sports & ICT and Finance & Social-economic Planning to increase the proposed allocation towards bursary

in the forthcoming supplementary budget to Kshs. 60 M, before submitting it to the Assembly for approval.
